Measles

- There is an outbreak in the United States 41 cases in 16 states
- Vaccination data for the U.S. could be better
- VT put out their own release recommending what people should adhere to

Respiratory Viruses

- RSV
 - Still active but a downswing in detections
- Flu
- VT continues to stand out with minimum activity, even though New England has more activity
- 37% of population is vaccinated
- COVID
 - o Low surveillance level in VT
 - Syndromic surveillance low
 - Mainly seeing 2 variants JN.1 and BA.2.86
 - 15 deaths in Vermont
 - Two new recent changes in guidance:
 - If you're over 65, the CDC is now recommending a booster of the current vaccine
 - 95% of those that have been hospitalized nationwide have not received any updated vaccine
 - Change in ending isolation: No more 5 day isolation period If you have no fever, are free of symptoms, people can go out and re-join society there is no firm advice, but just encourage people to take precautions (cleaner air, proper respiratory hygiene, wearing a mask, physical distancing, opening windows, testing is an option but not a requirement This if for the general community of people, not the medical community

PCB Testing in Schools

- 75 schools had no problem, 39 were above the school action level meaning they had some elevation
 16 of those 39 schools had an immediate action threshold met
- There will need to be future work done by the legislature perhaps slowing testing do not support ending altogether

Syphilis

• Vermont remains the lowest in the nation for chlamydia, gonorrhea, and syphilis

Opioids

- Have been providing a balanced approach to creating overdose prevention centers
 - VMS position: Knowing that the issue will be coming to the legislature and after extensive discussion, the Vermont Medical Society Board took a position in Spring 2023 in favor of supporting overdose prevention sites as part of a comprehensive harm reduction strategy and supported further exploration of the feasibility of establishing sites in Vermont. However, given limited funding and staffing resources, the Board also believes that there are other harm reduction strategies, such as increasing access to take home methadone doses, increasing transportation to hubs and mobile methadone units, improved transitions of care after incarceration, and reducing regulatory requirements on community MOUD prescribers, that should be a more immediate priority.
