



## Estimate Specialty Impact of CY 2024 Final Rule and Reduction in Temporary Medicare Conversion Factor Increase from 2.5% to 1.25%

**Note:** The temporary 2.5% Medicare Conversion Factor increase for CY 2023 is being replaced by a lower temporary 1.25% increase for CY2024, as per the Consolidated Appropriations Act of 2023.
